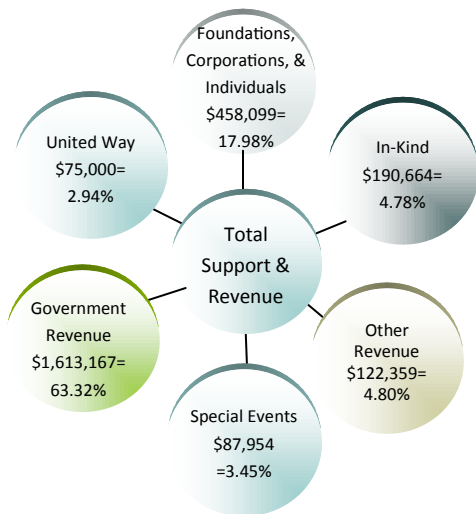

- Of the 261 women and children that exited Family Rescue’s residential programs in FY’15, 155 moved into safe permanent housing.
 - ◆ 61% of clients had maintained or increased their income from program entry to exit.
- 815 clients completed a safety plan for themselves or their family.
- 74% of children receiving services from the LCSW showed a decrease in behavioral and emotional problems.

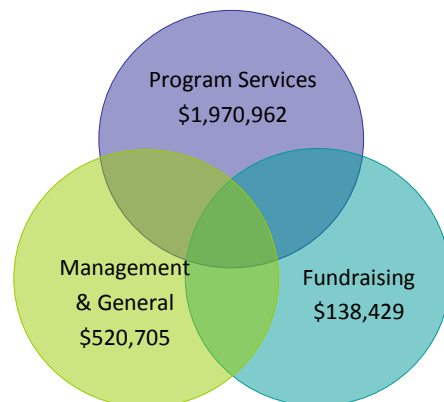
